On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am pleased to provide the enclosed NRC updated "Agency Declassification Compliance Plan," as requested in your letter of November 10, 2004. This plan has been developed to implement the provisions of Section 5.2(b) of Executive Order 12958, as amended, "Classified National Security Information."

In summary, NRC's declassification plan reflects a backlog of approximately 22 cubic feet of historical records that need to be reviewed by December 31, 2006. **Executive Order 12958, as amended,  
"Classified National Security Information"**

**A. Introduction and Background**

On March 25, 2003, the President amended Executive Order (EO) 12958 which among other things permits agencies to complete appropriate reviews of the backlog of classified permanent records that are 25 years of age by the end of 2006, and each year thereafter.

Pursuant to the provisions of EO 12958 agencies are required to establish, update, or revise agency declassification compliance plans outlining how each agency will declassify, exempt, or refer NSI that is eligible for review for automatic declassification.

**B. Scope**

The scope of this task is to update and revise, as appropriate, the existing Agency Declassification Plan to outline NRC's plans to declassify, exempt, refer, or delay all 25 year old NSI permanent historical records by December 31, 2006, and each year thereafter.

If NRC has no change in the information previously reported in the 2003 plan, a "No Change" is indicated.
