In response to the reference, enclosed is our Standard Form 311, Agency Security Classification Management Program Data for Fiscal Year (FY) 2010.

The Office of the Director of National Intelligence (ODNI) creates and classifies documents using the Central Intelligence Agency's (CIA) information technology infrastructure. For FY 2010, our Information Management (IM) office worked with the CIA to randomly identify internal ODNI users who could be surveyed in order to obtain an accurate sampling of derivative classification decisions (SF 311, Part D). Statistical sampling was used to obtain an estimate of the total classification decisions made by ODNI staff and contractor personnel.

The FY 2010 estimate of derivative classification decisions increased 7.6% to 1,762,999 from last year's total, while the number of decisions per person decreased by 8%. The increase in total decisions was largely driven by population growth, which increased by 17% from last year.

Regarding statistics relating to our declassification programs (SF 311, Parts E, F and G), the CIA provides declassification review services to the ODNI for legacy records. While we are enclosing review and declassification statistics, it is likely that some ODNI statistics may also be included in the CIA report.

Blocks 37/38: There were 270,079 pages reviewed that were subject to automatic declassification and 65,535 pages declassified. Blocks 41/42: There were two discretionary declassification decision made by the Acting DNI during FY10 (declassification of "QUILL" as a Radar Imager and declassification of the fact of "GAMBIT/HEXAGON" overhead ISR missions.
